Stakeholders Consultation Committee

This has reference to the recent amendment to Regulation 31A of Insolvency and Bankruptcy Board of India (Liquidation Process) (Second Amendment) Regulations, 2022 (“Amended Regulations”) and notified on 16-09-2022. As per sub regulation (1) the liquidator shall constitute a consultation committee, comprising of all creditors of the corporate debtor, within sixty days from the liquidation commencement date, based on the list of stakeholders prepared under regulation 31. Further as per Regulation 31 (11), if the Stakeholders Consultation Committee is constituted prior to the aforementioned Amended Regulations, the Liquidator shall re-constitute the Stakeholders Consultation Committee within 30 days of the said amended regulations.
